*da zastupa Davaoca punomoćja u svim pravnim poslovima vezano za otvaranje i vođenje računa Davaoca punomoćja (RSD, EU, idr.) kod Adriatic Banke a.d. Beograd, Dalmatinska 22, matični broj 07534183 (u daljem tekstu: Banka), a naročto da:*

- to open and to cancel bank accounts/ *otvori i zatvori račun;*
- to provide the Bank with all necessary documents and information required for opening and normal functioning of the bank accounts (as is having status of an official in terms of the regulations of the Republic of Serbia, residency status, consent to update and use my personal data in accordance with the internal Bank documents); *da Banci dostavi sva neophodna dokumenta i informacije potrebne za otvaranje i normalno funkcionisanje računa (kao što su informacije i dokumenta porebna da se utvrdi svojstvo funkcionera u smislu propisa Republike Srbije, status rezidentnosti, saglasnost za ažuriranje i upotrebu mojih ličnih podataka u skladu sa internim aktima Banke).*
- to dispose with funds on the account and sign orders for payment and transfer of funds without restrictions/raspolaže sredstvima na mom računu, izdaje naloge Banci zaplaćanje i prenos sredstava bez ograničenja;
- to sign all relevant agreements and bank forms for opening of bank accounts, usage of the internet banking and issuance of the payment cards/ *potpiše sve ugovore i formulare Banke vezano za otvaranje računa, korišćenje internet bankarstva i izdavanje platih kartica;*
- to receive from the Bank on behalf of the Principal any documents, equipment, payment cards, PIN code etc. in connection bank accounts; for the avoidance of doubt, the Principal confirms that he is aware that the authorisation for receiving of payment cards and PIN code practically enables uncontrollable unlimited disposal of the funds on the account/da od Banke u moje ime preuzme bilo koji dokument, opremu, platnu karticu, PIN kod i sl. u vezi sa računom; radi izbegavanja sumnje, *Davalac punomoćja potvrđuje da je upoznat da ovlašćenje Punomoćnika da podigne platne kartice i PIN kod, praktično omogućava nekontrolisano neograničeno raspolađanje sredstvima na računu.;*
- to announce to the Bank, on behalf of the Principal, any and all changes on the Principal's side (e.g. change of Principal's address, contact data, etc.)/ *da u moje ime obavesti Banku o bilo kojoj promeni (npr. Promeni adresu, kontakt podataka i sl.);*
- to perform any other actions which the Representative deems necessary to be performed for the purposes expressed in the paragraphs above/da sproveđe i sve druge radnje koje smatra da su neophodne u cilju sprovođenja gore nabrojanih ovlašćenja.

The Representative shall not be authorized to appoint his proxy. The power of attorney is executed in identical English (written in Arial font) and Serbian language (written in Arial Italic font) version and valid until **6 (six) months from the date of notarization** or until Adriatic Bank JSC Belgrade is notified this power of attorney has been revoked./ *Punomoćnik nije ovlašćen da prenese ovo punomoćje.
